What is the purpose of this update?

This document tells you how the Diversified 40 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. IOOF New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

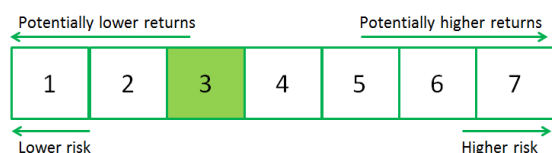
The Fund invests in a diversified portfolio containing both growth assets (shares) and defensive assets (fixed interest and cash). It has a slight bias to defensive assets and aims to generate consistent returns. Exposure to growth assets is obtained through investment funds operated by our Investment Manager. Investors are exposed to developed and developing economies through an efficient exposure to a highly diversified pool of assets, using both qualitative and quantitative investment techniques. Exposure to defensive assets is obtained through fixed interest and cash investments.

The growth assets of the fund are unhedged, while defensive assets are either fully hedged or New Zealand dollar denominated. Fund volatility is expected to be low to medium.

What are the risks of investing?

Risk indicator for Diversified 40 Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

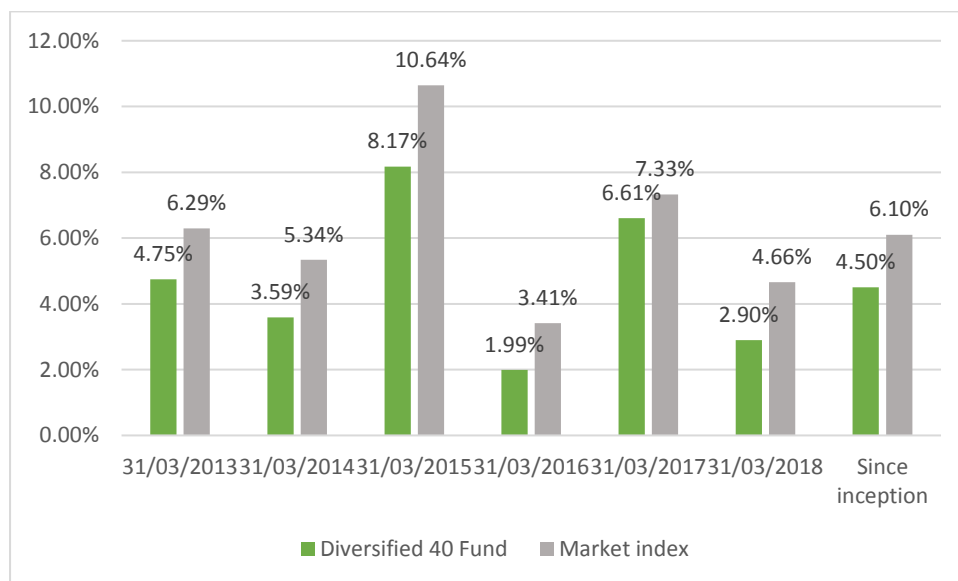

How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 September 2018.

Example of how this applies to an investor

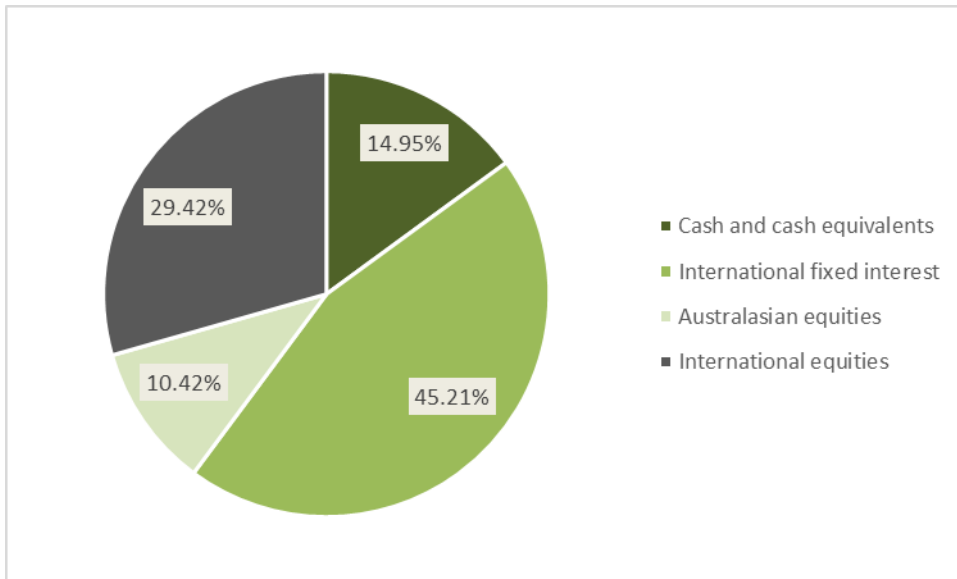
Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$642 (that is 6.42% of his initial \$10,000). Chris did not pay any other charges. This gives Chris a total return after tax of \$642 for the year.

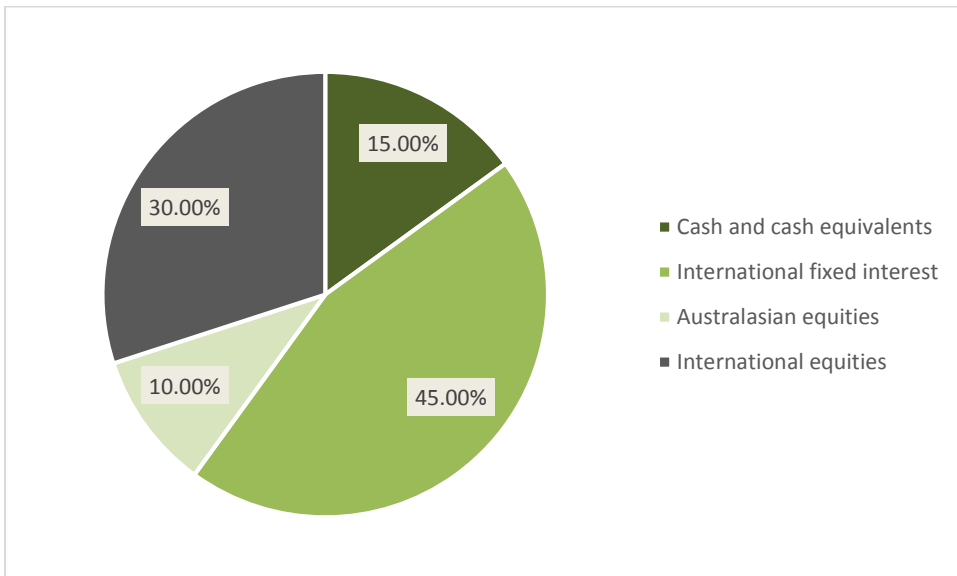

Note 1: The Manager's basic fee is a variable percentage up to 0.65%, and is charged to the investor rather than the Fund. The Other management and administration fee includes an estimate of the fees for investments into the underlying funds and is based on management fee rates disclosed by the underlying fund managers.
