#### What is the purpose of this update?

#### **Description of this fund**


The fund invests in international shares through investment funds operated by our Investment Manager, with a small allocation to cash for operational liquidity. It aims to achieve long-term capital growth through a structured exposure to listed global shares. Investors are exposed to developed and developing economies through an efficient exposure to a highly diversified pool of assets, using both qualitative and quantitative investment techniques.

The Fund is unhedged, and volatility is expected to be high.

## What are the risks of investing?



#### Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$139 (that is 1.39% of his initial \$10,000). Chris did not pay any other charges. This gives Chris a total return after tax of \$139 for the year.



Note 1: The Manager's basic fee is a variable percentage up to 0.65%, and is charged to the investor rather than the Fund.
